Reserved parking - maintaining the sanctity.

## Circular No. 12 – AG Dated: 14 .11.2022

It has been observed from quite some time, that the Law Officers/Govt. Counsel's and employees are placing their vehicles within the reserved parking of the authority, as a result there had been embracing position when the vehicle of the authority reaches office with its security fleet and visiting VIPs/ Pr. Secretaries /Commissioners/ Secretaries to Government, as a result the security personnel on duty at office has to cut a sorry figure. It has been further observed that the private vehicles of such Advocates/employees presently not working in the office are parking their vehicles within the designated parking area of Advocate General Organisaton resulting difficulties for all concerned.

It is to mention here that there is designated parking area separately for the Law Officers and employees of this office both at Srinagar and Jammu wings.

Therefore, in view of the above position and to maintain the sanctity of designated parking areas, it is hereby instructed that:-

- 1. None of the Law Officers/Govt. Counsel's /employees will henceforth park their vehicles in the reserved parking area of Ld. Advocate General, at Srinagar or Jammu.
- 2. All the Law Officers/Govt. Counsel's will park their vehicles in the reserved area for "Law Officers".
- 3. All the employees will park their vehicles/Scooters in their designated parking area.
- 4. In case non-availability of space within the designated parking area, the concerned shall be free to park his/her vehicle in general parking area of the High Court Complex.
- 5. In case of violation of above directions, the security personnel on duty will immediately report to the Traffic Police, for appropriate action.

6. All the vehicles shall at the front of dash board place Mobile Number and name for reference, if required.
