ORDER NO. 39 -AG of 2022

DATED: 15 -03-2022

Whereas, a separate Bench of Central Administrative Tribunal was established at Srinagar vide G.S.R. 805(E) dated: 17.11.2021 notified by Ministry of Personal, Public Grievances and Pensions (DoPT), Govt. of India.

Whereas, vide Govt. Order No.5960-JK(LD) of 2021 dated: 29.12.2021 issued by Law, Justice and Parliamentary Affairs Department, following three Law Officers were instructed to represent the Govt of UT before the Central Admn. Tribunal, at Srinagar Bench.

Whereas, it has been observed that these Law Officers are facing difficulties in representing the court cases due to non-existence of Record Keeping Sections and pursuation to line departments.

Whereas, the matter was examined, considered and found feasible to establish the Record Keeping Units and positioning of Record Keepers to pave way for smooth assistance to the Government Counsels in contesting the cases in a responsible / transparent manner.

Whereas, three CAT Sections have been established vide order No.38-AG of 2022 dated: 15.03.2022 in the Advocate General's Office at Srinagar Wing as under:-



The Head Assistant Srinagar will coordinate and ensure completion of task, under the overall supervision of Section Officer [A&C], within three days positively.
