Subject: - Promotion as I/c Junior Assistants - Withdrawal of orders thereof.

ORDER NO. 188 AG of 2023

Dated: 28 -11-2023

Whereas, two senior most matriculate orderlies viz; Mr. Mohammad Ashraf Dar and Mr. Baghwan Singh were vide this office Order No.AG/41/18 dated: 28.02.2018 adjusted temporarily against the available posts of Junior Assistant under Promotion Quota in their own Pay and Grade with Charge Allowance as admissible under rules.

Whereas, meanwhile J&K Advocate General's [Subordinate] Service Recruitment Rules came into existence vide SRO 225 dated: 25.03.2019. The requisite service in terms of Rule-3 of said Rules was accordingly constituted among others in respect of Class-IV Orderlies vide Order No.102-AGof 2020 dated: 21.12.2020, wherein both the above named employees figure among other Orderlies at appropriate place as on 25.03.2019.

Whereas, in light of rules, the type test notification was issued vide No.AG/Adm/220/506-11 dated: 21/12/2020 and Mr. Mohammad Ashraf Dar and Bhagwan Singh, Orderly I/c Junior Assistants appeared among other eligible employees for the type test conducted by Skill Development Department at Srinagar/Jammu ITIs on 24.02.2021 and 26.02.2021. On the basis of the result notification from Principal ITIs, Jammu/Srinagar Vide No. ITI/J/2021/1572 dated.10-03-2021 and No. Nil dated.05-03-2021, the result notification was issued vide No.AG/Adm-27/2020/921-24 dated: 23-09-2023, whereby the above named two incumbents were found "**Unsuccessful**". The matter was considered by the DPC in its meeting on 25.01.2021, and both the officials were not cleared while recommending conducting of the type test.

Whereas, both the officials were provided another opportunity for qualifying the requisite Type Test on computer key board, conducted on 18.08.2021 and 04.09.2021 at Srinagar/Jammu. On the basis of response from Principal ITIs vide No. ITI/Sgr/582 dated: 21.08.2021 and No. ITI/J/2021/538 dated: 09.09.2021, the result notification was issued vide No.AG/Adm-27/2020/921-24 dated: 23.09.2021 whereby again the above named two incumbents were found "**Unsuccessful**". The matter was considered by the DPC in its meeting on 26.03.2022, and both the officials were not cleared.

Whereas, thereafter the aforesaid officials were given final opportunity and both the officials appeared for the type test conducted through Skill Development Department on 25.09.2023 and 16.10.2023 at ITI Srinagar/Jammu respectively. On the basis response from Principal ITIs, the result was notified vide No.1471-75 dated: 24-11-2023, which reveals that both the officials have again failed to qualify the requisite type test under rules.

Whereas in view of being temporary arrangement, both the officials are figuring in the seniority list of MTS [Orderly] as issued as on 01.01.2023.

Whereas, in view of the above elaborative position, Mr. Mohammad Ashraf Dar and Mr. Bhagwan Singh, MTS [Orderly] have failed to qualify the requisite Type Test, despite providing ample number of chances for paving way to their regularization/confirmation against the post of Junior Assistants by the DPC. The DPCs have also considered their cases and were not cleared for obvious reason.

Now, therefore, in terms of J&K Advocate Generals [Subordinate] Service Recruitment Rules, 2019, the temporary adjustment/stop-gap arrangement of Mr. Mohammad Ashraf Dar and Mr. Bhagwan Singh, MTS [Orderly] as I/c Junior Assistant ordered vide this office Order No.AG/41/2018 dated: 28.02.2018 is hereby rescinded. Both the officials will continue to work as MTS [Orderly] henceforth as such duties assigned to them.
